Although conservationists recognise the biodiverse significance of most sacred natural sites, the role of spiritual agency by other-than-human-persons is not well understood. Consequently, sacred natural sites typically lack legal status and IUCN-designated protection. More recent ecocentric and posthuman worldviews and polycentric legal frameworks have allowed courts and legislatures to grant 'rights' to nature and 'juristic personhood' and standing to biophysical entities. This book examines the indigenous literature and recent legal cases as a pretext for granting juristic personhood to enspirited sacred natural sites. The author draws on two decades of his research among Tibetans in Kham (southwest China), to provide a detailed case study. It is argued that juristic personhood is contingent upon the presence and agency of a resident numina and that recognition should be given to their role in spiritual governance over their jurisdiction. The book concludes by recommending that advocacy organisations help indigenous people with test cases to secure standing for threatened sacred natural sites (SNS) and calls upon IUCN, UNESCO (MAB and WHS), ASEAN Heritage and EuroNatura to retrospectively re-designate their properties, reserves, parks and initiatives so that SNS and spiritual governance are fully recognised and embraced. Moving back and forth between micro and macro in a continual interplay across individuals, groups, and institutions, and organizing their experiences and philosophies of teaching under the rubrics of Playing, Haunting, Silencing, Unbecoming, Leaking, Befriending, Slipping,

and Reassembling, Anne and Jody try out alternative tales, exploring a pedagogical orientation that is ecological in the largest sense, engaging teachers and students in re-thinking learning and teaching in classrooms, and in their larger lives, as complex, enmeshed, volatile eco-systems. Jody and Anne weave through their own voices those of students and colleagues, demonstrating the complex playfulness of collaborative and transdisciplinary forms of teaching and learning. Not solving the contradictions, but abstracting from the immediate, they offer a dialogue, telling hard stories and funny ones, involving others' stories in response, demonstrating the complex playfulness of collaborative and transdisciplinary work. She works with readers and writers in Philadelphia county jails and Pennsylvania state prisons, where they search for personal, political and transformational responses to their shared questions about accountability and equity. Robinson later said that his faith in God had sustained him—giving him the strength he needed to play the game he loved at the highest level without retaliating against the abuse inflicted upon him by opposing players and fans. Faith was a key component of Robinson's life, but not in the way we see it with many prominent Christian athletes today. Whereas the Tim Tebowski and Clayton Kershaw of the sports world emphasize personal spirituality, Robinson found inspiration in the Bible's teachings on human dignity and social justice. He grew up a devout Methodist (a heritage he shared with Branch Rickey) and identified with the theological convictions and social concerns of many of his fellow mainline Protestants—especially those of the Black church. While he humbly stated that he could not claim to be a deeply religious man, he spoke frequently in African American congregations and described a special affinity he and other Black Christians felt for the biblical character Job, who had also kept faith despite suffering and injustice. In his eulogy for Robinson, Jesse Jackson described Robinson as a "co-partner of God," who lived out his faith in his civil rights activism, both during and after his baseball career. Robinson's faith will resonate with many Christians who believe, as he did, that "a person can be quite religious and at the same time militant in the defense of his ideals."
